

What Is Most Important to Our Identity?

The Association for Canadian Studies commissioned this poll from Environics Research Group/Focus Canada. The survey of 2,002 Canadians 18 years of age and over looks at issue of identity in Canada. The ACS-Environics survey was carried out by telephone from March 15-23, 2003. Results are accurate to within plus or minus 3,5%, 19 times out of 20.

When Canadians are asked what is most important to their identity, the most obvious cleavage in results arises between francophone and anglophone Canadians. As the 'first' response to the question, francophones cite language as most important to their identity and culture while anglophones refer to ancestry and ethnic origin as somewhat more important than language, which ranks a close second.

The difference between French and English respondents is reflected in the regional breakdowns of the most important identity markers. There is a fair degree of consistency in the pattern across the country. Beyond the divide over religion, political ideology and gender are stronger outside of Quebec than within the province.

Amongst immigrants one observes that persons of European extraction tend to regard language as the most important part of their identity and culture whereas those of non-European origins tend to choose language, ancestry & ethnic origin and religion to fairly similar degrees. This may be especially relevant given that the fastest growing segment of the population is persons of European descent.

On the basis of age, ancestry and ethnic origin is clearly more of a factor for people under the age of 60, whereas religion becomes more relevant to those persons beyond that age.

On the basis of party preference the most interesting difference is between those supporters of the Bloc Québecois, for whom language is especially relevant, and those supporters of the Canadian Alliance, where language is the second choice behind ancestry and ethnic origin and religion holds stronger importance than is the case for others.

Respondents listed a second identity marker. On this 'second' marker, there is little difference between English- and French-speaking Canadians, though French-speaking Canadians still place language slightly higher in importance.

Non-European immigrants are far more likely than European immigrants to mention language as their second marker. Ancestry and ethnic origin is the most often mentioned for European respondents.

Some differences by political preference include a higher percentage for Ancestry and ethnic origin (32%) and Political ideology / orientation (20%) by Bloc Québecois supporters and 18% response for Social Class by NDP supporters.
